

Competition terms and conditions – “Do business with TMR and win a hotel break”

1. Competition organiser

The Competition - “Do business with TMR and win a hotel break” (hereinafter referred to as “**Competition**”) is organised by the Tatry mountain resorts, a.s. company, with the registered office at Demänovská Dolina 72, Company number: 31 560 636, registered in the Commercial Register of District Court Žilina, Section: Sa, Insertion No.: 62/L (hereinafter referred to as “**Organiser**”).

The Competition Organiser is hereby publishing these Competition Terms and Conditions (hereinafter referred to as “**Rules**”). The main purpose of the Competition is to support and promote the Organiser in the field of MICE segment.

Conditions of participation and the Competition itself are governed only by these Rules, which define the terms and conditions of participation in the Competition. The Rules and conditions of the Competition can be changed only by the Organiser and the change must be made in writing in the form of an addendum.

2. Conditions of participation in the Competition

Any **legal entity** that fulfils the Competition conditions (hereinafter referred to as “**Participant**”) can participate in the Competition.

If the Organiser finds out about or has reasonable suspicion of fraud and/or unfair practises related to a Participant or another person that might have helped the respective Participant win the Competition, they shall not be given the winning prize(s). If a person who has been forbidden to take part in the Competition has already been given the winning prize, they are obliged to return the prize to the Organiser.

The Organiser reserves the right to exclude any Participant from the Competition at Organiser’s sole discretion and in any phase of the Competition if the Participant’s behaviour and actions may stain the reputation of the Organiser or affect the rights or legitimate interests of third parties in any way.

The Organiser reserves the right to exclude any Participant from the Competition in case they are suspected of violating the Rules or doing actions which are against the Rules.

3. Competition duration

The competition takes place **from 1.4.2019 to 30.11.2019**.

4. Competition rules

The Competition is meant for legal entities that follow all applicable terms and conditions and organise their corporate events at one of the below listed accommodation facilities operated by the Organiser or the EUROCOM Investment, s.r.o. company, with the registered office at 136, 034 83 Bešeňová, Company number: 35 756 985, or the Tatry Mountain Resorts CR, a.s. company, with the registered office at Pobřežní 18/16, 186 00, Praha 8, Czech Republic, Company number: 06871917:

and book at least 10 rooms per event (hereinafter referred to as “**Corporate event**”).

Every Participant who:

- books a Corporate event at the Organiser (i.e. makes the first contact with the Organiser regarding the respective Corporate event during the period of the Competition duration); and
- organises their Corporate event

between 1.4.2019 and 30.11.2019 can participate in the Competition

if they cover all financial obligations related to the Corporate event.

Every Participant who participates in the Competition and fulfils the above mentioned terms of Competition participation can win a prize.

One winner can win one prize per calendar month during the period of the Competition duration. Every winner will be drawn by the Organiser on the fifth working day of each month (the drawing shall be related to the previous month). Every prize will be drawn by a random picker from among all Participants who have organised their Corporate events during the respective calendar month. If any Corporate event is more days long, the decisive day as for the prize draw shall be the first day of the Corporate event. The first prize draw takes place in May 2019, the last one in December 2019.

Every Participant can join the Competition only once. If any Participant organises more Corporate events during the period of the Competition duration, they shall participate in the prize draw only based on the first Corporate event. Their second and all other Corporate events shall not be taken into consideration regarding the Competition.

5. Competition winning prizes

There is one winning prize per one calendar month, i.e. 7 prizes during the period of the Competition duration. The prizes are given to the winners in the form of vouchers that can be used at the Green Inn hotel, Ostravice, Czech Republic, or at the Kaskáda hotel, Kuřim, Czech Republic. Every voucher applies to 4 people and 2 nights in a Standard room including breakfast, free entry to the hotel wellness centre and golf academy services. The Organiser is entitled to choose any of the two above mentioned hotels for each calendar month during the period of the Competition duration. All winning vouchers are non-transferable.

Voucher validity period:

a) Vouchers related to Corporate events held until 30.9.2019 are valid until 21.12.2019.

b) Vouchers related to Corporate events held from 1.10.2019 to 30.11.2019 are valid until 31.10.2020 (except the Easter period).

Every hotel break can be booked no sooner than 7 days prior to arrival in High season and 14 days prior to arrival in Low season. Every voucher can be used based on the availability of accommodation and the reservation must be confirmed in writing. In periods with a high occupancy rate, the operator of the accommodation facility reserves the right not to confirm reservations of vouchers even if the respective accommodation is available via other sales channels. The vouchers do not include local charges for guests staying in the area which have to be paid when checking in. High season and Low season terms as well as all other details related to the booking process are governed by the General Terms and Conditions which are published on www.tmrhotels.com.

Every original voucher has to be presented when checking in at the accommodation facility.

When booking a hotel break via the reservation department, clients are obliged to inform the agents about the payment with a voucher in advance and specify the voucher number.

6. Taking of the winning prize - place, procedure and designated period

Every Competition winner shall be contacted by the Organiser via an event coordinator or a sales representative. Every voucher will be sent to the address of the winner via the Slovak postal service. To book a hotel break that is covered with a winning voucher, every winner shall contact the reservation department of the Organiser directly.

Shall the winner not be interested in receiving the winning prize, refuses to take the prize, fails to meet the Rules, or the Organiser fails to contact the winner within two working days after the Competition is evaluated and the winner is informed, the prize will be given to another participant who is drawn afterwards and fulfils all Competition terms and criteria.

The Competition results are final and cannot be appealed against. The winning prize is non-transferable, cannot be changed as the winner wishes and the winner is not entitled to ask for financial compensation instead of the prize. In accordance with § 845 Act No. 40/1964 Coll. Civil Code, the prize is not enforceable through the court.

7. Special provisions

The Competition Organiser reserves the right to decide about any terms and conditions of the Competition at their own discretion and the right to limit, postpone, interrupt, amend or cancel the Competition at any time due to specific reasons. The Organiser is not responsible for any technical or programme errors that arise during the Competition.

The winning prize can be subject to taxation in accordance with Act No. 595/2003 Coll. on Income Tax as subsequently amended. The tax as well as other financial duties that can be related to receiving a winning prize shall be paid by the winner in full amount as defined by the law.

8. Protection of personal data

The competition Organiser, i.e. the operator, i.e. the Tatry mountain resorts, a.s. company, with the registered office at Demänovská Dolina 72, 031 01 Liptovský Mikuláš, Company number: 31 560 636, registered in the Commercial Register of District Court Žilina, Section: Sa, Insertion No.: 62/L processes personal data in accordance with the general binding law of the Slovak Republic, mainly the General Data Protection Regulation (GDPR) and Act No. 18/2018 Coll. on the Protection of Personal Data.

9. Final provisions

Ignorance of these Competition Rules does not entitle anybody to make a claim and such claim shall not be taken into account.

By taking part in the Competition, the Participants agree with the Competition Rules. The winning prize shall not be given to a Participant who does not agree with these Rules without reservation and does not meet all conditions resulting from these Rules.

The Rules are governed by the law of the Slovak Republic.
